#### Responsibilities of Anti-Ragging committee:-

On receipt of the recommendation of the Anti Ragging squad or on receipt of any information concerning any reported incident of ragging the head of institution shall immediately determine if a case under the laws is made out if show either on his own or through of Anti- Ragging committee authorized by him in this behalf proceed to file a first information report (FIR) with in 24 hour of receipt of such information or recommendation with the police and local authorities under the appropriate panel provisions relating one or more of the following namely.

- Abetment to ragging
- Criminal conspiracy to rag
- Un law full assembly and rioting while ragging
- Public new sense created during ragging violation of decency and morals through ragging
- Injury to body, causing hurt of grievous hurt
- Wrongful restraint
- Wrongful confinement
- Use of criminal force
- Assault as well as sexual offences or unnatural offences extortion
- Criminal trespass
- Offences against property
- Criminal intimidation
- Attempts to commit any or all of the above mentioned offences against the victim (s)
- Physical and psychological humiliation
- Other offences following from the definition of Ragging

#### Responsibilities of Squads In-Charge Anti-Ragging committee:-

- They will form duty charge and carry out regular checks for any Ragging activity in their areas
- They will carry out surprise checks in probable areas of Ragging
